Based on Article 105, Article I 12.2 of the Law on Public Procurement of Kosova, supplemented and amended by Law 04/L-237, Law 05, L-068, and Law 05/ L-002, as well as Article 48 and Article 50 of the Law on General Administrative Procedure Law No. 05/L-031, regarding the procurement activity “Construction work for the implementation of the detailed project (main implementer) of architecture and engineering for the construction of the new Stadium in Peja, in accordance with category III of the regulations and technical guidelines for stadium infrastructure, approved by UEFA (Second re-tendering)” with procurement number: 207-25-10662-5-1-1. initiated by the contracting authority (CA) Ministry of Culture, Youth and Sports, on the 10.07..2026, has issued this:

CONCLUSION FOR CORRECTING THE DECISION

The sentence in the last paragraph of the Decision with protocol no. 2026/0267, dated 10.07.2026 on page 28 of this decision, which remained as a technical error, is amended/corrected according to the description which we will reflect in this conclusion::

Part:

The review panel, after administering and evaluating the evidence, fully ascertaining the factual situation, relying on the LPP as the applicable material law, after reviewing the complaint claims, taking into account all the case files and the expert's recommendations, has found that the complaint of the Economic Operator "Pro&Co Group" SH.P.K. is approved as grounded, consequently the Review Panel has decided to confirm the decision of the CA Ministry of Culture, Youth and Sports regarding the procurement activity "Construction work for the

implementation of the detailed project (main implementer) of architecture and engineering for the construction of the new Stadium in Peja, in accordance with category III of the regulations and technical guidelines for stadium infrastructure, approved by UEFA (Second re-tendering)" with procurement number: 207-25-10662-5-1-1.

Corrected/supplemented

The review panel, after administering and evaluating the evidence, fully ascertaining the factual situation, relying on the LPP as the applicable material law, after reviewing the complaint claims, taking into account all the case files and the expert's recommendations, has found that the complaint of the Economic Operator "Pro&Co Group" SH.P.K. is approved as partially grounded, consequently the Review Panel has decided to annul the decision of the CA Ministry of Culture, Youth and Sports regarding the procurement activity "Construction work for the implementation of the detailed project (main implementer) of architecture and engineering for the construction of the new Stadium in Peja, in accordance with category III of the regulations and technical guidelines for stadium infrastructure, approved by UEFA (Second re-tendering)" with procurement number: 207-25-10662-5-1 -1.

Reasoning

In connection with the drafting of the Decision PSH no. 2026/0267, dated 10.07.2026, it is found that a technical error has been presented on page no. 28.

This technical error is corrected/supplemented by this conclusion, taking into account that the appeal of the complaining Economic Operator was partially approved by the Review Panel according to the reasoning in the decision, respectively, the necessary changes have been made to the Decision in question according to this conclusion.

The Chairman of the Review Panel, after being notified of the technical omissions identified in the aforementioned Decision and in accordance with Article 50 of the Law on Administrative Procedure, Law No. 05/L-031, hereby corrects the technical error in the reasoning part of the decision.
